Job Summary

The purpose of this position is to maintain Museum facilities through cleaning, minor equipment repair, arrange set-ups as needed for events, and supervise Community Service workers to ensure work is accomplished.

Essential Duties & Responsibilities

- This position's normal work week will be Wednesday Sunday.
- This position will lead the weekend staff to accomplish any set-ups and turn arounds needed, especially on Saturday and Sunday.
- Work closely with Special Events, responding to set-up needs when required to ensure that our guests' needs are met.
- Setting up or rearranging furniture in the auditorium, galleries and other rooms to conform to scheduled activities.
- Execute preventative maintenance program on various types of facilities equipment as directed.
- Perform routine maintenance as directed.
- Direct the work of the Community Service workers sent to assist in cleaning
- Perform janitorial duties as required.
- Assist with installation and de-installation of exhibits as needed.
- Flexibility in reporting for work in addition to normally scheduled hours during emergency situations and special events.
- Be observant and make suggestions to Director of Buildings and Grounds that would improve safety or security
- As with all staff, security of the Museum collections is a priority
- Other duties as assigned by the supervisor

Qualifications and Experience

- Requires experience in basic maintenance and janitorial tasks
- Ability to work with staff and guest using good judgment, tact, and polite communication
- Ability to respond quickly and independently when jobs need to be done
- Ability to take direction, and assist other departments as directed by the Director of Buildings and Grounds
- Ability to operate cleaning machinery, phone system, service elevator, pick up truck, and other maintenance related equipment.
- A valid PA Driver's license is required
