WE LOOKED FOR INNOVATIVE WAYS TO CONTINUE TO ENGAGE VISITORS WITH ALTERNATIVE PROGRAM OFFERING INCLUDING DRIVE BY EDUCATIONAL KIT PICK UP AND VIRTUAL TOURS.

TEMPORARY OR SPECIAL EXHIBITS AND PERMANENT COLLECTION - THROUGHOUT THE YEAR THE MUSEUM PROVIDES PATRONS THE OPPORTUNITY TO SEE EXHIBITS CREATED BY OTHER MUSEUMS OR COLLECTIONS FROM PRIVATE COLLECTORS AND UNIQUE ITEMS FROM THE MUSEUM'S OWN COLLECTION. IN 2020 WE WELCOMED 21,367 GENERAL VISITOR ADULTS AND CHILDREN TO THE MUSEUM AND 5,195 VISITED THE NEAG PLANETARIUM AT THE READING PUBLIC MUSEUM.
