WE ALSO SAW SUBSTANTIALLY INCREASED TOUR ACTIVITY WITH 10,489 MUSEUM TOURS AND 10,271 TOURS TO THE PLANETARIUM. TOURS ARE AVAILABLE TO PRE-K TO SENIOR GROUPS, CUSTOMIZED TO MEET THE EDUCATIONAL NEEDS OF THE SPECIFIC GROUP AND PROVIDED BY PROFESSIONALLY TRAINED MUSEUM PERSONNEL.
